# ON WEDNESDAY 15<sup>TH</sup> JANUARY 2014 IN THE VILLAGE HALL.

**Present:** Councillors Dean, Carter, Petrie, Bashford, Anderson, Smith, Hall, Schofield, Mease (Chairman), the Clerk, Central Beds Councillor Mrs Turner and 16 members of the public.

- 1) Apologies: None.
- 2) Declaration of Interest: Councillor Anderson re White Gables Farm.
- 3) Minutes of the meetings held on 20<sup>th</sup> November and 18<sup>th</sup> December 2013

  Mr Dean proposed the minutes were a true record of the meetings this was seconded by Mr Smith and agreed.

The Chairman welcomed Andrew Gwillam Rights of Way Officer for Central Beds Council. Mr Gwillam explained his position and what his job entails. He explained the Definitive Map for the area which he had brought with him, a copy would be put on the village notice board. Residents could contact him anytime they wished if they had a question or a problem by phone or email. He advised that CBC carried out a clearance campaign twice a year. Requests for clearance can be notified where work is required. Explaination was given that some well walked paths may not be on the map, and cross field paths are the responsibility of the landowner. Attempts are being made to upgrade paths some into cycleways. The Chairman thanked Mr Gwillam for attending.

- 4) Parishioners questions. The meeting closed.
- 5) Planning reports.

Applications received:

 Park Road Farm......change of use from agricultural to D1, larger outbuilding to be used as an exhibition area, smaller outbuilding to be used for practical teaching workshops related to agriculture and horticulture.

- No objections raised in principle, but concern at the increase in traffic along Park Road and the numbers of people visiting the site.
- 2) Sue Ryder Home, St Johns Road.....TPO works to T1 Oak and T2 oak and T5 Lime including reduction and removal of deadwood. No objections raised.
- 3) 59 Park Road....erection of anew timber framed detached garage to the rear of the property and replace concrete driveway and hard standing surrounding house with cobble style block. No objections raised.
- 4) White Gables Farm......change of use of existing grain store building to a mixed use grain store and haulage( ClassB8). Objections raised as for previous applications for this site including all activities carried out on the site, an enforcement was in place. A vote was taken 4 in favour and 4 against the Chairman used his casting vote to request the planning officer to refused the application.

### 6) Highway reports:

Mr Dean attended the Central Beds Conference. The meeting was first addressed by the Ollie Martin the Police Commissioner who advised that the were now200 Special Police Officers in service, and he hoped to raised the number to 400. The precept would have to be raised as he had to cut 7 million from his budget proposals. There are now only two centres of operation these are at Luton and Bedford.

Central Beds will be gritting the main highways, bus routes and school routes. Improvement schemes included addressing speeding and parking on yellow lines.

The Highway maintenance contract will be up for renewal in 2016. The service contract with the liaison engineer is good in Moggerhanger.

The supply of salt for the bin has been delivered to White Gables Farm for storage, Mr Dean will organise and carry out getting the salt in smaller bags to enable the salt to be put in the bin.

#### 7) Central Beds Council report.

Mrs Turner a consultation will be advertised on the Draft Budget which was agreed 14<sup>TH</sup> January, all savings had been earmarked.

The Gypsy and Traveller Strategy was discussed at the Scrutiny Meeting and a report will be put to Council on 30<sup>th</sup> January giving the proposed sites, Chalton was not included. The plan will then be for a 6 week consultation prior to being submitted to the Secretary of State in June when it is hoped it will be adopted.

A meeting of the Ivel Parish Forum will be held on 16th January in Ickwell, the main item for discussion will be Communication., but Average speed cameras will also be discussed.

The next Central Beds Town and Parish Council Conference will be held on 29th April, topics for discussion were requested.

#### 8)Playing field report;

Football is still being played despite the poor weather, there is hope for a seconded team for next season.

The ROSPA Inspection will be carried out in May.

Mr Anderson advised the tractor used for cutting the grass in the field will no longer be available. A quote will be sought for the contract.

A meeting will be called before March to discuss work required in the play area.
